CLOSED SESSION

 - Approve the implementation of restrictions to assist in preventing the Individual from choking based on a special diet as recommended by Eastern State Hospital's speech and dietary departments.
 - Eastern State Hospital will present an update at the end of the first 90 days to discuss the status of the restrictions, at the January 2020 LHRC meeting.
- Recommendations for MPNN
 - o Motion made Ms. Racioppi, seconded by Mrs. Brooks, and unanimously approved by the committee members as follows:
 - Approve the next friend designation.
 - MPNN will present an update at the end of the first 90 days to discuss the status of the designation, and progress or lack thereof, at the January 2020 LHRC meeting.
- Representatives from B&M Residential arrived to the meeting just prior to the meeting being adjourned. However, the committee agreed to hear the request provided all necessary documentation was available.
