A quorum was present. Supt. Chris Walz; Ms. Krasinda Barton; Pam Westbrook; Deborah Hand; Capt. Barnes; Capt. Bhagirath; Jeff Rosen, Esq.; April Brumley; Rebecca Hopkins.

#### Call to Order

- Sharon Scott (hereafter, CS) called a emergency meeting of the Hampton Roads Regional Jail Authority to order at the Hampton Roads Regional Jail, 2690 Elmhurst Lane Portsmouth, Virginia 23701, on the 15th<sup>th</sup> day of April at 1:30 p.m. in the large training room.

#### Opening

- CS opens the meeting welcoming everyone.

#### Covid-19 Virus Emergency Plan & Continuity of Operations for HRRJ

- Col. Walz – I'd like to first start off by saying that no staff member or incarcerated individual has been diagnosed with Covid-19. Our population has not shown any sign or symptoms. We have had 11 staff members who may have come into contact but have been in isolation after they have spoken with a physician. I also would like to thank the staff here at HRRJ. For the month of February we had on average 4 people per day out sick and for the month of March we only had about 2 per day out. I can't thank staff enough for showing up and coming to work.
- Col. Walz – I'd like to review some of the procedures we have put in place since this started. We had all staff members have their temperatures taken prior to coming into the building and we also had them fill out a questionnaire. Also, I'd like to thank all the

jurisdictions. We have all agreed to hold individuals for 14 days prior to transferring anyone. Once they arrive here at HRRJ we are placing them in quarantine for an additional 72 hours. Temperatures are also being read in our intake area. We have partnered with our phone provider to give each inmate one free video visit per week. Attorneys also have free video visits. If the need arises we do have 4 negative pressure rooms within the facility that we can use. Civilian staff that have the ability to work from home they have been given permission to. They are required to come in once a week to obtain their work.

- Col. Walz – We have ordered PPE but as everyone knows there is a nationwide shortage. We have partnered with The Office of Emergency Management and placed an order for PPE through them. We have about 260 N95 masks and we have a order of KN95 masks coming in this week. We have a large supply of gloves, hand soap, hand sanitizer, and other cleaning equipment.

Gabe Morgan – Do you have any face shields, surgical masks, or gowns?

Col. Walz – Yes. Our medical department has masks, gowns, and gloves, head covers, and ponchos.

Gabe Morgan – If you don't have any face shields I think we can get some to you. You would need to have some handy in the event that you have someone who is positive.

Bob Geis – How many days of supplies do you have? Mask wise.

Pam Westbrook – For the N95 we have about 15 days worth that would include what our medical department has and what the facility has. That would be enough for security and medical department on an as needed basis for 2 weeks.

Gabe Morgan – Just as a thought, if you end up with one positive person and they are on a watch event for every 15 minutes then you will burn through that PPE.

Pam Westbrook – Our corporate office is trying to get more masks for this facility especially because of the acutely level we have here.

Jim O'Sullivan – We were lucky enough that we had an order put in very early for N95 masks. We are able to hook up with the City and we have a company that is cleaning the masks. So, we have issued all of our employees 2 masks. They wear one mask for 5 shifts and then they turn that in to be cleaned and then they automatically go to their next one and we re-supply them with another one. If you have enough masks would you think about doing something similar for your employees?

Col. Walz – Yes sir. If you could share that information we can use it.

Bob Geis – I have that companies information. I will get that out to everyone as soon as possible.

### **Approval of Minutes**

- CS allowed time for the Members to review the minutes.

- CS asked for a motion for the Board to approve the minutes from February 19<sup>th</sup>. Gabe Morgan moved to approve the minutes. Alan Archer seconded. A voice vote was taken with a unanimous vote. The Motion Carried.

### **Treasurer's Report**

- Deborah Hand – Medical is high but should even out with True-ups hit.
- Gabe Morgan moved to accept the treasurer's report. Bob Geis Seconds. A voice vote was taken with a unanimous vote. The motion carried.

### **Review of operations and Activities**

#### **Medical**

- Pam Westbrook – I would first like to announce that we do have a new director of Nursing. His name is Darrian Bock. We also have Dr. Moreno in this meeting if anyone has any questions. Since the last board meeting we have 46 patients (hereafter Pt) receiving medications for HIV. For the Temporary Detention Orders currently it is 6 for the month of March. We have 10 pregnant females in the facility. 2 are currently on Opiate Replacement Maintenance. We have 23 Pts with Cancer. 1 Pts receiving radiation. Within the facility we have 14 men over the age of 65 and we have no females over 65. In reference to the special needs list we have 7 Pts with paraplegia. 14 that are intellectually delayed and 7 receiving dialysis. We have 1 total care Pt. We are issuing out masks for anyone going out for outside appointments. Due to Covid -19 surgeries are scheduled on a case by case basis. The Doctor will call the hospital and they will discuss to see if it is an urgent or emergent need.

#### **Security**

- Capt. Bhagirath – For our jurisdictional runs for the city of Chesapeake – 42 runs, Hampton a total of 60, Newport News a total of 64, Norfolk 78 and Portsmouth had 29. Transportation runs to include courts, bonding and releases to total 273. We had 3 trips to DOC, 20 to Maryview Hospital, 34 to Norfolk General, 6 runs via ambulance, 16 ER runs by jail transport, 107 scheduled medical appointments, and 11 runs to the mental health facilities. If you include everything it is 470 and then the return trips to the facility are 426, for a grand total of 896 transportation runs.

#### **Human Resources**

- April Brumley – We currently have 13 vacancies. For the month of March, we had 3 immediate resignations. We also had 2 terminations that were no call no show for 3 or more shifts. We had several recruitment events lined up but because of Covid-19 those have been canceled. As a result we have moved to aggressive recruitment online via, indeed, Facebook, Linkdin, as well as our Website. We have switched from face to face interviews to phone interviews and video interviews when possible. We are actively interviewing and testing applicants on a weekly basis for the position of Jail Officer. We

have received an update from Bon Secures who is our occupational health provider and they are implementing a Covid-19 questionnaire screening for all new hires.

### **Maintenance Projects**

- Capt. Barnes – On the records and classification side we had a total of 264 new intakes and a total 305 releases. We have a current count of 903. We have done a total of 4 special approvals. We have done 223 Video Hearings during the start of this pandemic.

### **Mental Health Grant**

- Bruce Hurdle – For the month of March we have had 70 referrals and out of those 57 were enrolled with the grant. We had 6 TDO request and all of those have been approved. We have suspended program activities due to Covid-19. We do now have Clinical therapists. They will be providing programming as soon as available. We plan to use Changing Lives and Changing Outcomes as our programming once we open things back up.

CS – Does anyone have anything else they would like to say before we adjourn?

Jeff Rosen – I just want to mention that because the courts have been shut down, cases are not being set for trial. Just to update everyone on our law suit cases. As far as the DOJ, I have been in contact with them and they understand that we cannot discuss the proposed settlement agreement until after the Covid-19 Crisis is resolved because we cannot go into closed session.

CS – That is all of our agenda items. I would entertain a motion to adjourn. Linda Curtis Motioned for adjournment and Martin Thomas seconded. A voice vote was taken with a unanimous vote. CS adjourned the meeting.

The next meeting is scheduled for May 20<sup>th</sup>.

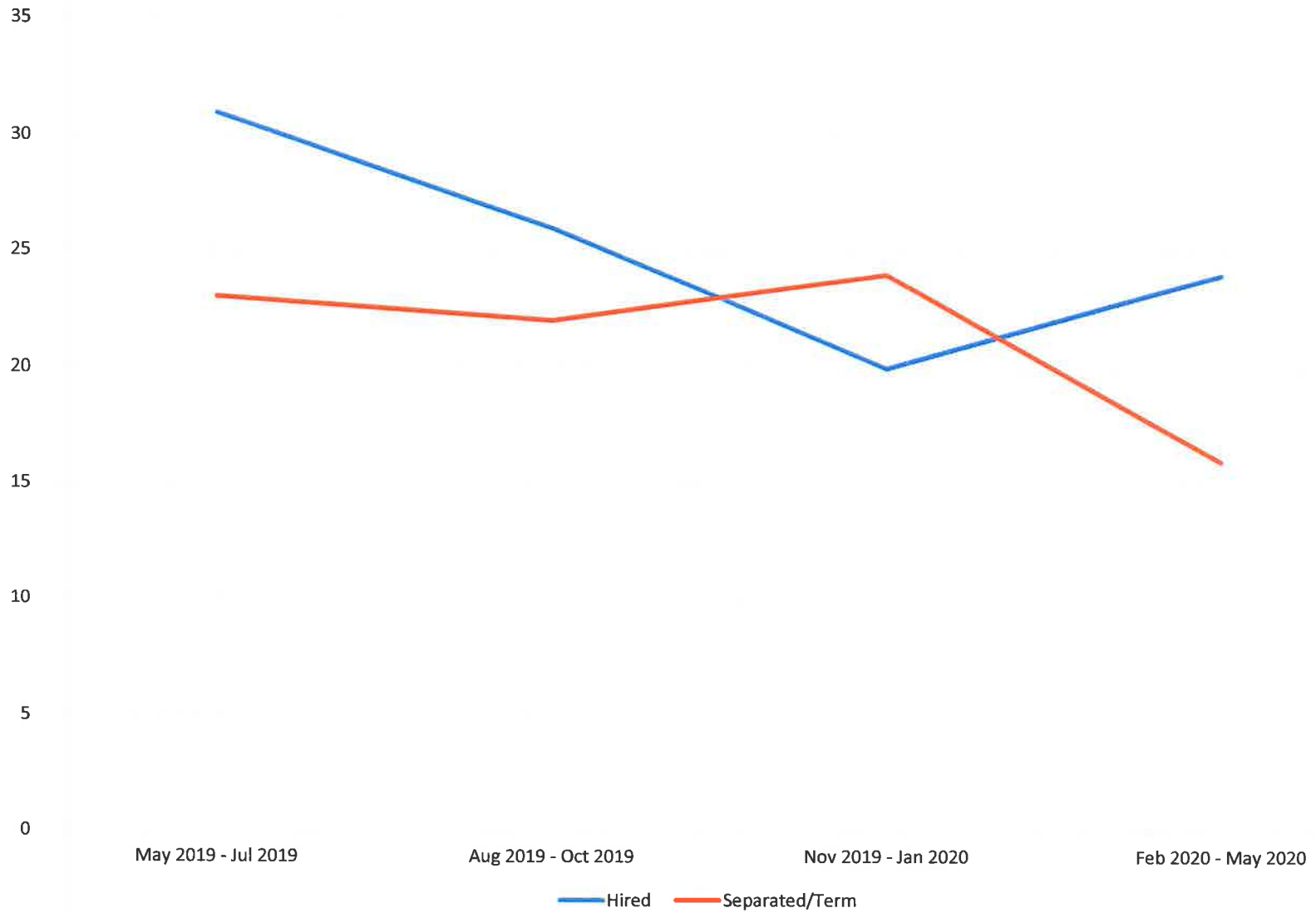
