Public Comment

Leni Gonzalez of Arlington commented on behalf of the League of United Latin American Citizens (LULAC). LULAC has concerns about the response to assist the Latino communities in the state during the pandemic. Stated Latinos represent about 10% of the state population, but 60% of the COVID-positive

cases. Gonzalez is also concern with the end of the eviction moratorium, specifically in Northern Virginia, and the lack of bilingual/bicultural contact tracers.

Michel Zajur commented on behalf of the Hispanic Chamber of Commerce. He stated PPP loans are still available. Latinos are not obtaining these types of loans. The Chamber does webinars in Spanish on how to get these loans and grants and offers one-on-one appointments. The Chamber is also putting together the most comprehensive list of Latin businesses in the state. The Chamber's annual Que Pasa Festival will be held virtually this year during Hispanic Heritage Month. The Chamber will also be promoting a Hispanic Restaurant Week.

Vilma Seymour with LULAC in the Richmond Region echoes Leni's concerns. Stated lots of issues in Richmond region that need to be addressed in regards to COVID.

Chris Falcon of Arlington, former VLAB member, wanted to commend the Board for being at the forefront of the COVID response. Commented that he would like the board to keep the eviction moratorium in mind. Stated there are enormous problems with housing insecurity. Urged the board to reach out to nonprofits in our areas to ensure they are receiving funding for rent payments.

Jorge Ivan Soto introduced himself as the new VLAB intern. He studies public policy at the University of Chicago.

Chair's report (Paul Berry) 9:55 AM

Our work should not stop there; I am still greatly concerned with health services that could be made available to qualifying Virginia residents through emergency Medicaid expansion. The Department of Housing and Community Development requested \$200 million dollars for the rent relief program, and with a discussion later today I hope we can recommend that this issue be taken up during the special General Assembly session. Also, we have a great opportunity to seize the headwinds of an employment and diversity discussion. We can talk about these during new business.
- For now, I'm thrilled to see you all here, and I look forward to our discussion.

Karina Klein-Gabel asks if Governor provided any sense of how they are handling the disparities with COVID.

Paul Berry responds by stating the Governor focused on the communication issue.

Latino Outreach Update (Maribel Castañeda) 10:06 AM

The Latino Outreach weekly emails are transitioning to Constant Contact. VLAB supported the Governor's bilingual press conference in Fairfax. Thanks to Paul Berry, Sergio Rimola and Cecilia Williams. That was followed by a roundtable discussion. They are still organizing concerns and following up with specific organizations in Northern Virginia.

19 Latinos have applied for service on a state Board or Commission since the last VLAB meeting. Continue encouraging others to apply. Maribel also stated she is continuing to work on Hispanic Heritage Month activities and supporting messaging around the Census and COVID-19

Education and Workforce Development Committee

The Committee met with Secretary Qarni. They have developed the following recommendations:

- Legislative Recommendations
 - Fully fund and better fund the state's educational budgets to address those disparities exacerbated by the pandemic
 - Require increased diversity at all agency levels
 - Establishing permanent D&I policies
 - Increasing TANF and SNAP funding
 - Increase the minimum wage
 - Relief funds for those impacted by layoffs due to the virus

- o Administrative
 - Education
 - Data-driven dashboard report on data-oriented goals focused on outcomes for Latinx faculty and students
 - Strengthening education, recruitment and retention of Latinx educators
 - Implementation of in-state tuition for immigrant students
 - Evaluating and changing policies and practices that perpetuate systemic racism
 - Allowing ESL students to stay in public school to age 22
 - Workforce Development
 - Open and accessible government services
 - Establishing a dashboard with goals for diverse and equitable employment
 - Increase in appointment of Latinx officials in government
 - Bilingual/bicultural communications and outreach staff in government agencies
 - Clarifying worker rights during the pandemic
 - Protecting migrant and seasonal workers

Health Committee

Cecilia Barbosa provided the following recommendations on behalf of the Health Committee

- No immigration status check or ICE involvement
- Spanish-language helpline for those who need testing
- Develop set of coordinated strategies to address prevention and treatment as well as the socioeconomic consequences of COVID.
- Treatment
 - Medicaid emergency service for COVID testing
 - Paid leave for COVID-19
 - o Access
 - Translation of materials and data
 - Increasing funding for interpreters
 - Behavioral health
 - Access to community health workers

Business Committee

Paul Berry provided the recommendations on behalf of the Business Committee.

- Change reporting requirements for immigration officials (shall not report misdemeanors)
- Hire staff for Chief Data Officer
- Hire inspectors to combat wage theft
- Expand authority to investigate employee wage complaints
- Provide PPE for workers
- Create an emergency childcare fund

- Condition receipt of financial aid to businesses that have retain staff
- Broadband expansion for Latino communities

Civic Engagement Committee

Karina Kline-Gabel provided the recommendations on behalf of the Civic Engagement Committee

- Charge the Secretary of Administration to develop plans for voter franchise expansion
- Correct disparities to voting during the pandemic
- Ensure Spanish-language website accessibility
- Translate the entire Board of Elections website to Spanish
- Bring on VLAB interns
- Encourage 211 to open regional offices
- Continue promoting Census 2020

Housing Committee

Carmen Romero reported that the committee met with Erik Johnston, Director of the Departmental of Housing and Community Development. The Committee makes the following recommendations:

- Expanding eviction prevention programs
- Rent relief programs targeted towards those who cannot access traditional programs, such as undocumented Virginians
- \$50 million rent relief program for populations of color
- Production of affordable housing through the Housing Trust Fund (HTF)
- Right to counsel for tenants as a defense to eviction proceedings
- Eliminating the provision of attorney's fees in eviction cases for plaintiffs
- Proper notice for evictions
- Including legal aid information on all eviction notices
- 6-month financial relief to landlords
- Translated rental agreements available in Spanish
- List of tenant/landlord rights available to all Virginia renters
- Statewide initiatives on patterns of segregation in the Commonwealth
- Development of a housing equity taskforce
- Addressing mobile home parks and manufactured housing

Misc. Board Business (10:35)

Carmen Romero introduced a letter to Gov Northam asking he consider a statewide eviction moratorium for 45 days. Explains there will be a resurgence or eviction cases. The moratorium would allow relief money to make its way to the hands of renters.

Motion: Carmen Romero moves to send the letter to the Governor requesting he consider an extended statewide eviction moratorium for 45 days. Paul Bery seconded.
