ADVOCATE REPORT AND TRAINING

Andrea Milhouse provided reported that there should be two hearing scheduled between April and May and requested that all members please be available for those hearings.

Amaya Henderson is the new LHRC support staff. Members will be seeing information come from her office.

In the fourth quarter 2021, there were 798 reported allegations of abuse/neglect with 31 substantiated. There were 35 complaints submitted with one violation upheld.

After a meeting with the Directors and LHRC Chairs, it was requested that trainings not be held during the regularly scheduled meetings. They will now be offered quarterly.

Membership Attendance: It was discussed that members can only miss 33% of meetings, per the by-laws. Because this committee meets quarterly, that would be equivalent to missing one meeting. Members can ask to be removed from the committee if they do not feel that they can fulfill this requirement. Members who miss 33% will be brought forward for a vote for removal.
