ADVOCATE ANNOUNCEMENTS

- LHRC Responsibility Guidance: The LHRC should review any restriction on the rights of any individual imposed pursuant to 12VAC35-115-50 or 12VAC35-115-100 that lasts longer than seven days or is imposed three or more times during a 30-day period. Behavioral treatment plans should be reviewed in accordance with 12VAC35-115-105.
- Look Behind Process – The Office of Human Rights is currently undertaking a process into reviewing CHRIS reporting and investigations. Regional Advocates have been assigned to review specific cases throughout the state to ensure consistency statewide in the advocate's investigation process.
- Minutes for the LHRC are currently being posted to the Commonwealth Calendar.
- The Human Rights Regulations were updated and made effective on February 9, 2017. The Office of Human Rights, in collaboration with staff from the Office of the Attorney General, offered multiple statewide training opportunities. Training for the LHRCs is currently being created and will be presented to the LHRC upon completion.
