Grace Reynolds

- Language Access money trying to get the money to ONA perhaps include language access coordinator. 2.5 million FY 2023
- Refugee funding \$2 million FY 2023 ONA focused on certification and licensing.
 Susannah never made available to refugee resettlement agencies. Restrictive need to be extended and broadened.
- Board handbook in the works.
- Strategic Plan in the works for ONA. Also identifying areas of collaboration with ONAAB. Potentially Board objectives as well.
- 5 million Fed Funds DOE Afghan support. Partnership ONA holds funds.
- 3200 Ukrainian arrivals Ukrainian Unite
- Work with Islamic relief to become resettlement agency?
- Resource mapping meeting in NOVA (Seyoum, Kendra and Grace).
- At VCCI meetings ONAAB members should identify as advisory board members.

Immigration trends and possible reforms

Public attitudes about Immigration

- More people think immigration is a positive ~70% 2022
- Political ideologies tend to have similar overall leanings, but vary to extent exceptions in deportation of illegal immigrants and pathways to citizenship.
- Foreign Born Demos
- 10th largest FB population in country
- 1.2% 1950-12.4% 2020
- 25% of children under age 18 in US FB
- Unauthorized Population
- Border encounters crossing no longer seasonal, those who come are staying.

- And now, more who enter illegally, not from Mexico more from deeper south American countries due to turmoil in countries.
- Title 42 repatriations due to pandemic restrictions. Spikes in 2021, due to multiple attempts.
- Humanitarian Migration
- Asylum: 743K in immigration courts in 2022 508k asylum seekers at USCIS in 6/22
- DACA: 594k as of 6/22
- TPS currently 16 countries mostly El Salvador, Honduras and Haiti 417k in 11/18
- Afghan Parolees 70k as of 11/22 36,400 no pathways to permanent residence
- Legal Immigration
- Historically 6 million backlogs. Current backlogs at USCIS 9 million applications per year take 8-9 months to process applications. Due to hiring freeze in 2020-2021. Net impact in VA – people not getting processed and not getting work authorizations etc.
- USCIS entirely funded by immigrants themselves application revenue. No funding for asylees and refugees. Personal note – need to provide some type of funding for asylees and refugees.
- What is proper mix? Total 1,085,000 total Granted LPR 2017-2019
 - Family sponsored 66% (718k)
 - Employment 13% (138K limit 140K)
 - Humanitarian 13% (146k)
 - Diversity 4% (47k)
- Naturalizations projected to increase in 2022 to more than a million
- Questions reforms:
 - Permanent
 - What is the proper mix of legal immigrants
 - Effects of country caps and category limits
 - Backlog processing
 - Waiting list for those with approved petitions
 - Temporary
 - Not enough seasonal
 - Unauthorized
 - Increased border security
 - Employer sanction enforcement modifies Asylum procedures
 - Legalization/removal/status quo
 - Dreamer/DACA
 - Humanitarian
 - Processing delays
 - Rebuild resettlement structure
 - Afghan pathway adjustment
 - Hire more immigration and asylum officers

Hassan -

- Firm works with 3 refugee resettlement agencies (CCC, IRLC, CWS) has taken on 200 asylum cases. Have filed 60-70 cases. Have encountered issues that have complicated filing of asylum cases. Complications include trauma, emergencies, housing, employment etc. As an ONAAB member, has a dual role here. CCC has asked Hassan to raise the issue with ONAAB. Applauds accommodations file within 45 days and get decision within 145 days. It is difficult with complications that the 2 years of parole will be insufficient to get asylum applications filed. Most October of 2023, parole status will run out. TPS could be relevant, but is another application that requires time and resources.
- Another problem, because parole status will run out, serious looming problem with work authorizations. I-765 work permits delays for some 330-365 days to process. If an Afghan parolee and cannot file asylum in time and could lose work permit.
- Not as simple as filing early for asylum, there are trust issues (misinformation) and lack of resources.

- CCC asks that ONAAB/ONA advocate for an executive order to extend parolee status.
- Also want ONA to understand these issues and to work with immigration attorneys staff to address concerns (funding, resources and timelines).

Grace – can work with Seyoum to open dialogue. **Susannah** – funding – slow to work through system
