10:40 a.m. Meeting Minutes and Meeting Agenda – Lyons Sanchezconcha, Chair of VLAB

Jo Ann Chase motioned to approve the March meeting minutes

Alex Guzman seconded the motion

Juan Vega motioned to approve the May meeting agenda

10:43 a.m. Public Comment - Lyons Sanchezconcha, Chair of VLAB

Public comment provided by Maribel Castañeda, former Director of Appointments under Gov. Northam. She thanked the Board members for their service and said that we are a voice for our underrepresented communities.

10:50 a.m. Administrative Updates – Eric Conyers

Change from agenda, Emma Jenson cannot attend, but Eric Conyers is here to assist

Chair Sanchezconcha recognized Micheal Perez as the state deputy director of DOI

Joshua DeSilva asked Michael Perez about the comments from the state’s Chief DEI Officer about “DEI” being “dead,” and asked if there was any follow up. Michael Perez stated there was no follow up. Asked if they could meet with VLAB, Michael Perez stated there was no reason to rule that out.

Juan Espinoza shared about Virginia Tech as an example of you can increase diversity without decreasing merit

Rodrigo Soto mentioned recent reporting stating that the Youngkin administration has made whiter and more male appointments than previous administrations

Lyons referenced that the word “equity” has become taboo, but equitable measures such as HBCU scholarships and Women in STEM initiatives have come out of the Governor’s administration; discussion around this is pertinent and applicable to work of the board

10:58 a.m. Listening Session Recap – Lyons Sanchezconcha, Chair of VLAB

9 attendees in addition to the VLAB representation were present at the Sacred Heart Center.

The focus was on education due in part to attendance from the Richmond Public Schools. One stat that was shared is that there is only one interpreter for the entire district available at RPS. Board discussed ways to advertise and get the word out about listening sessions moving forward.

Paul Berry discussed the Board’s statutory role as the “formal liaison between the Latino community and the Governor’s Office.”

11:10 a.m. Right Help, Right Now Overview, Deputy Secretary James Williams, Health & Human Resources

Dep. Secretary Williams discussed details of implementation of the Governor’s Right Help, Right Now plan focused on mental health services statewide. The 988 mental health crisis line is now available statewide to provide mh crisis services. Language access is a focus of the program including Spanish language counselors. Crisis receiving centers are a focus to help eliminate the

criminalization of mental health. Joshua DeSilva asked about implementation of Right Help, Right Now on college campuses and in schools. Dr. DeSilva also asked about language access and cultural competence in the roll out. Dep. Sec. Williams stated that the department intends to hire a consultant to provide recommendations on language access. Juan Vega and Jo Ann Chase mentioned the needs of elderly Virginians. Dr. DeSilva recommended to Dep. Sec. Williams that HHR's VMAP program includes cultural competence and language access. Lyons Sanchezconcha mentioned the need for trauma informed care for school based providers and gave the example of a lockdown at a Richmond high school.

11:45 a.m. Chair's Report – Lyons Sanchezconcha, Chair of VLAB

Chair Sanchezconcha thanked Board members for their service. The Chair reminded everyone of the [Code of Conduct from the Secretary's Office](#) to ensure effective board meetings. As of today, we will have a first draft of the annual report.

Provide \$1M in state funding to George Mason University towards the Virginia Small Business Development Center program for the course of two fiscal years to hire bilingual advisors.

Provide zero-fare public transportation to Virginians:

- **Support and expand** the Virginia Department of Rail and Public Transportation (DRPT) Transit Ridership Incentive Program (TRIP) funds for the purpose of providing zero-fare grants to jurisdictions throughout the Commonwealth.
- **Support** the passing of the federal Freedom to Move Act, whose purpose is to provide federal funds for fare-free public transportation.

Create a Marketing & Communications plan to better disseminate information about state resources, both to the community and internally within state departments including a Tip Line for

Virginia residents

- **Launch** Estamos Contigo Campaign
- **Create** a dedicated hotline for Latino business owners to share their ideas with us. Provide funds for the printing of a half million bilingual postcard-size flyers with the hotline telephone number.
