

DRAFT MINUTES
Milk Commission Meeting Held October 18, 2017

Minutes of the meeting of the Milk Commission, held at the Farm Credit of the Virginias, 4646 South Valley Pike, Harrisonburg, VA 22801.

THE COMMISSION:

ABSENT:

Patrick Crawford, Commissioner; Jay Swanson, Commissioner

Gerald Heatwole called the meeting to order at 1:30 p.m.

Gerald Heatwole asked for a motion to accept the minutes from the previous meeting. Robb Watters so moved and Kate Farmer seconded the motion. The minutes were accepted as presented.

Crafton Wilkes noted that Commissioner Jay Swanson was unable to attend as he was currently adapting to life as a father after the birth of his daughter, María Christina Swanson. James Kerr was then introduced as the latest appointment to the Board as a producer member. He is co-owner of Ameva Farms in Amelia County, and serves as President of Cooperative Milk Producers Association in Blackstone. He fills the vacancy left by Ken Smith.

Crafton Wilkes gave a review of Class I prices, noting that forecasts indicate that producer prices appear to have peaked for the next several months. He cautioned that forecasts are subject to change, and that even in a month's time, figures have fluctuated by as much as \$0.50 per hundredweight. The effect of several new retail options on milk sales in the state was discussed. Virginia has experienced an influx of grocery retail stores over the last two years, and online ordering has impacted the way consumers purchase milk. Neither has shown a noticeable increase in fluid milk purchasing at the retail level.

Crafton Wilkes presented requests for distributor licenses for three companies. All applicants agreed to comply with the Rules and Regulations of the Commission during initial hearings with Commission staff, and report Virginia milk sales to the Commission through a monthly report. Through a motion so moved by Robb Watters and seconded by Bruce Mayer, the board approved the applications.

Gerald Heatwole discussed the current struggles that dairy farmers in Virginia face, emphasizing that succession by the younger generation of farmers was challenging in part because debt loads are increasingly prohibitive to a successful transition. Kate Farmer asked how farmers could cope under such circumstances. Eric Paulson, Executive Secretary of the Virginia State Dairyman's Association, provided detail, explaining that most farmers either developed a niche market or expanded to capitalize on economies of scale. He noted that since 2014, the number of dairy farms in Virginia has decreased from 620 to 540, but dairy cow numbers and overall production has remained stable.

The next Commission meeting date was scheduled for December 12, 2017 at 1:30 p.m., at the Virginia Department of Forestry in Charlottesville, VA 22903.
