# **ICT Training: Apple Accessibility Training**

Paul Mordan, Rafi Guroian and Dave Marra from Apple Government provided a hands-on information and communication technology training (ICT) titled "Accessibility at Work". The objective of the training was to inform the audience and demonstrate assistive technology features built into Apple devices (phone, iPad and Mac) for personal accessibility. Apple provides this training to state agencies and local governments to demonstrate how these new features facilitate inclusion and empowers employees to be more productive in the workplace. Apple's five pillars of accessibility include vision, hearing, speech, mobility and cognitive solutions. Participants were encouraged to bring their own Apple devices or use loaner equipment for the four-hour in person hands-on training in order to explore these accessibility features built into Apple devices.
