**Approval of January 4, 2024, Meeting Minutes**

## **Program Reviews:**

### **Report by Kyle Waters - USDA Wildlife Services Report**

- The team consists of 7 part-time employees covering all Virginia counties.
- Last year, Wildlife Services:
  - Provided direct control services to 117 livestock farms.
  - Offered technical assistance to 303 farms.
- Sheep predation by coyotes decreased by 40%.
- However, the predation by Black Vultures increased.
- The new sub-permitting program to control Black Vultures has been very effective.
  - This year, 111 sub-permits were issued to farmers to help them manage black vulture damage efficiently.

### **Report by Cecil King – New River Valley Sheep & Goat Club**

- The G.O.A.T (Greatest of All Time) Festival was held in September 2024 at the New River Valley Fair Grounds in Dublin, VA.
- The festival attracted over 2,000 spectators.
- For the upcoming year, the festival will lose its \$3,500 premier sponsor.
- Mr. King reported on sheep sales in Southwest Virginia through local livestock markets.
  - 22% of lambs sold in Virginia originate from Southwest Virginia.
- The next G.O.A.T Festival is scheduled for September 27, 2025.

### **Report by Dr. Scott Greiner – 2024 State Fair Lamb Carcass Contest**

- 2024 marks the 26th year of the Lamb Carcass Contest, held in conjunction with the State Youth Market Lamb Show.
- Dr. Greiner provided a detailed written report on the Lamb Carcass Evaluation (see Attachment #1).
- The program offers market lamb project participants a viable opportunity to receive fair market value for market lambs weighing 135 lbs. or more.

## **Member Term Update**

Tracy Fitzsimmons reported that the Virginia Sheep Industry Members had been appointed by the Governor and had been notified with a term expiring 6/30/28 except for the following that have not been reappointed as of the meeting date:

- Virginia Livestock Markets Representative

The Governors Office was given a list of nominees at the end of May to fill the expired seats.

## **OTHER BUSINESS:**

- **New Logo Presentation**  
The Board was presented with the newly designed logo, which will be used for official letterhead, marketing materials, and promotional activities.



- **Carcass Project Funding**

The Board discussed the carcass educational support line introduced in the FY21 budget, intended to assist local clubs and organizations in promoting lamb carcass education, primarily through ultrasounding lambs at county fairs. The primary focus was the existing base reimbursement rate of \$5 per animal, capped at 100 animals.

- Motion by Larry Weeks to increase the reimbursement rate to \$10 per head, maintaining the maximum of 100 animals.
  - Second by James Mumaw.
  - The motion passed unanimously.

- **Fund Request – Application Process**

- Discussion focused on streamlining the fund request process for the Virginia Sheep Industry Board (VSIB).
- A new fillable PDF form will be created and made available to organizations and producers requesting funds.
- The form will be accessible on the VSIB website and will include a submission deadline.
- The Board discussed aligning the application deadline closely with the next board meeting to facilitate timely review.
