## **Other Grant Proposal discussion included:**

### **Grant# 26-1: “Grassroots to Global: Local Cattle Focused on National Productivity”**

Becky Roberts, VCE Pittsylvania County, provided more information to the Board on the full plans of the PCCA and how the VCIB funds would be utilized. McNeil made a motion to approve the grant request. Threewitts 2<sup>nd</sup> and motion passed. Shelton sustained from voting.

### **Grant# 26-5: “Effects of Duckweed Supplementation on Digestibility, Ruminal in Situ Nutrient Disappearance, Microbiome, and Fermentation Parameters in Forage-Fed Beef Cattle”**

Overall, the Board felt that this was too much money for too small of an audience/impact in would have on the industry. Threewitts made a motion to deny the grant request. Jones 2<sup>nd</sup> and motion passed.

### **Grant# 26-6: “Does the Source of Trace Mineral Supplementation Influence Fiber Digestibility in Beef Cattle”**

The Board felt that much of this research has already been done and is available to the public. McNeil made a motion to deny the grant request. Threewitts 2<sup>nd</sup> and motion passed.

### **Grant# 26-7 “Virginia Women in Agriculture: Cattle Women Increasing Skills and Education (WISE)”**

Becky Roberts and Amy Byington gave a brief presentation to the Board pertaining past Cattle WISE programs and the success accompanied with them. Following their update, they highlighted their plans for the upcoming Cattle WISE program and how the funding would be utilized if granted. Tucker reiterated to both Roberts and Byington that the while the Board wants to continue support for the program, they would like to start scaling back in their commitment for future years. Smith made a motion to pass the grant as requested. Shelton 2<sup>nd</sup> and motion passed.

### **Grant# 26-9: “CRISPR and the Future of Virginia Beef Production: Engaging Producers Through Research and Education”**

The Board felt that this grant request allocated a substantial amount of funding for personnel and tuition while also questioning the true need for the project. Multiple Board members felt that the outcome of the grant project would ultimately be filled by private industry as they will capitalize on the utilization of CRISPER in Virginia’s beef industry. McNeil made a motion to deny the grant request. Smith 2<sup>nd</sup> and motion passed.

### **Grant# 26-10 “Enhancement and Expansion of Electronic marketing Strategies for VA Premium Assured Heifers; Scott County”**

McNeil made a motion to fund Grant 26-10 at \$2,500 for general marketing purposes. Shelon 2<sup>nd</sup> and motion passed.

### **Grant# 26-11: “A Survey of Plant-Parasitic nematodes Parasitizing Alfalfa with an Emphasis on *Ditylenchus Dipsaci* in Virginia”**

The Board ultimately did not feel that the outcome of the project would be widespread enough to justify the cost to producers. Threewitts made a motion to deny the grant request. McNeil 2<sup>nd</sup> and motion passed.

### **Grant# 26-13: “Savor the Sizzle, Promoting nutrition, Consumer Confidence, & Vitality of Virginia Beef Through a Farm to Table Dinner”**

The Board felt that this project was more regionalized, and the benefit would result more to a single private entity rather than overall support to the greater beef industry in Virginia. Jones made a motion to deny the grant request. Smith 2<sup>nd</sup> and motion passed.

**Grant# 26-15:** *“Growing the next Generation: Hands-On Beef Quality Assurance Training for Virginias Future Agricultural Leaders”*

Many felt that approving grant request 26-15 would open the door for all FFA chapters to start requesting money for localized use. The Board emphasized their preference to support BQA promotion and training at a state or regional level, helping to spread the VCIB dollars over a greater area. McNeil made a motion to deny the grant request. Shelton 2<sup>nd</sup> and motion passed.

**Grant# 25-16:** *“Spectral Sensing for Forage Quality and Ergovaline Content Monitoring”*

Some Board members questioned the science behind the project and thus the full value of the outcome. Threewitts made a motion to deny the grant request. Jones 2<sup>nd</sup> and motion passed.

**Grant# 26-17:** *“Virginia Beef Liquidity Initiative; Experiential Finance Education for VVB Supply Chain Success”*

Threewitts made a motion to approve grant 26-17 at \$6,258 - deducting the \$3,000 sponsorship to the Kohl Center Agri-Food Finance (AFF) Fellows program. The \$500 support of a graduate student fellow to provide technical and econometric assistance to the AFF Fellows and undergraduate team would remain in the budget. McNeil 2<sup>nd</sup> and motion passed.

**Grant# 26-18:** *“2025 Augusta County 4-H Meat Judging Team Journey to the national 4-H Meat Judging Contest”*

Shelton made a motion to support grant 26-18 in the form of a \$2,000 sponsorship. Smith 2<sup>nd</sup> and motion passed.

**Grant# 26-22:** *“Virginia Verified Beef”*

After much discussion amongst the Board, and many questions for Reeves (VCA), McNeil made a motion to approve the grant at the full requested amount. Jones 2<sup>nd</sup> and motion passed. Smith sustained from the vote.

**Grant# 26-24:** *“Effects of Supplemental Glutathione on Cattle Exposed to Fescue Toxicosis Under Heat Stress Conditions”*

Some Board members questioned the Boards favor for funding \$11,900 in Personnel and Benefits. Huffman made a motion to approve at the fully funded amount. Smith 2<sup>nd</sup> and motion passed on a vote of 6-1.

**Grant# 26-25:** *“In Vitro Evaluation of Doses of D-Limonene on Ruminal Fermentation of Forage- or High Concentrate-Based Diets”*

The Board felt that the requested amount of funding was higher than the overall value the research would have on Virginia’s beef industry. McNeil made a motion to deny the grant request. Threewitts 2<sup>nd</sup> and motion passed.

**Grant# 26-26:** *“Central Virginia Cattlemen Association Special VQA Sale on August 7, 2025, in New Holland, PA”*

McNeil made a motion to approve grant 26-26 at \$2,500. Smith 2<sup>nd</sup> and motion passed.

## **OLD BUSINESS:**

### **Other Business**

#### **Website**

Shelton made a motion to continue services with Flair Communications to provide website hosting & update services through the 2026 year. Threewitts 2<sup>nd</sup> and motion passed.

#### **Virtual Meeting Policy**

Matthew Sponaugle presented the current Virtual Meeting policy to the Board. Smith moved to renew the policy for the FY25/26 year. McNeil 2<sup>nd</sup> and motion passed. The policy will be updated in the Handbook.

#### **Grant Amendments**

Four grant amendments were presented to the Board pertaining to budget changes and term extensions. McNeil made a motion to approve all amendment request as presented below. Smith 2<sup>nd</sup> and motion passed.

- 1) A no cost term extension for Grant 25-4 was requested through March 31, 2026. The extension is necessary to allow additional time for molecular testing of field samples. No additional funds for the grant were requested.
- 2) A budget change was requested for Grant 24-9B, requesting \$3,000 of funds be moved from Contractual to the Materials & Supply line item. Reasoning gave included the fact that water access points at the SPAREC needed modifications to complete the project. John Fike felt that they could contribute additional labor to the project cutting back on the Contractual needs. No additional funds were requested.
- 3) A no cost term extension for Grant 25-20 was requested. The extension is necessary to allow additional time to process blood analysis that still needs to be run. No additional funds for the grant were requested. The term extension will go through February 28, 2026.
- 4) A no cost term extension for Grant 25-17 was requested. The extension is necessary to due to setbacks and delays caused by Hurricane Helene. Amy Byington did add that the cookery class had been re-scheduled for August 9 and the Bootcamp for November. No additional funds for the grant were requested. The term extension will go through February 28, 2026.

#### **Future Meeting Date**

The next meeting date is tentatively set for Thursday February 13, 2026.
